#### 1. FOREWORD:

Punjab Skills Development Fund (PSDF) is the largest skills development fund in Pakistan. PSDF was established in 2010 as a not-for-profit company set up under the Companies Ordinance 1984 by the Government of Punjab (GoPb). PSDF offers quality demand driven skills training to vulnerable and poor youth of Punjab helping them to create sustainable income generation opportunities in Pakistan and beyond.

Punjab Skills Development Fund (PSDF) and Oil and Gas Development Company (OGDCL) have joined hands for skills enhancement initiative and launching "Youth Skill Development Program". The program will equip the poor and vulnerable in the OGDCL operational districts in Punjab and provide them with income generating and sustainable employment opportunities.

PSDF will shortlist the institutes for the association as per the criteria mentioned in this document. The aim of the 'Skills Scholarship Model' is to empower the trainees to choose among the associated institutes for skills training in the desired field.
