Sealed bids/proposals are invited from bidders for “Disposal of Vehicles of PSDF” to PSDF. All interested and eligible bidders are requested to go through the Tender document and provide relevant information along with supporting documents mentioned in this tender document and must be submitted in **hard form**.

2 Instructions For Bidders

2.1 Terms & Condition:

This disposal of vehicles of PSDF is subject to the following terms and conditions.

1. Unsealed/open bid(s) shall not be entertained.
2. PSDF reserves the right to accept or reject any/all proposals/bids without assigning any reason(s) thereof.
3. Bid should accompany the following / Eligibility conditions:
 - a. Signed declaration form that bidder is not-blacklisted (as per format at Section 7 – Affidavit)
 - b. NTN & PST/GST (where applicable) must be registered and active as the case may be.
 - c. **10%** earnest money of the total bid amount in form of **Pay Order** in favor of “Punjab Skills Development Fund” (NTN: 3704870-8). Bids received without earnest money shall not be entertained.
4. Each bidder shall be required to submit earnest money equivalent to **ten percent (10%)** of their total bid amount **separately** for **each vehicle** on which they **place a bid**.
5. If the bidder fails to provide information as per the above-mentioned or does not fulfil the requirement of, “Eligibility conditions” shall be disqualified and declared ineligible from the bidding process and its financial evaluation shall not be carried out.
6. Bid(s) should be valid for **180 days** commencing from the bid closing date.
7. No offer/bid shall be accepted after bid closing time and date.
8. All applicable (direct & indirect) Govt. taxes i.e., WHT (10 % for filer & 20% for non-filer or any tax as per the applicable law) shall be paid by bidder over and above the successful bidder price. Any change in the Tax Slab will be deducted in accordance with the provisions of Government Rules amended from time to time.
9. Transfer letter of Vehicles will be issued in the name of successful bidder only. Transfer charges will be borne by successful bidders.
10. Complete files (if any) and registration books of each vehicle are available with PSDF.
11. The token taxes before the handing over of the vehicle by the successful bidder shall be the responsibility of PSDF.
12. All logistics, transportation and handling charges shall be borne by the potential buyer at the time of inspection of the vehicles and for picking up the same from PSDF’s premises.
13. The highest offer in each vehicle would be considered the successful bidder, however, in case the successful bidder fails to submit the balance amount, his earnest money would be confiscated by PSDF, and if PSDF Disposal Committee agrees then the second highest bidder would be considered the winner if they match the price quoted by the highest bidder.
14. Bid price below the reserve price will not be acceptable, decision of PSDF in this case shall be considered final.
15. PSDF will negotiate with the highest bidder to get further improved offers.
16. Envelope should be marked with “**Vehicles No.**”.
17. Balance of the bid amount as per the filling status to be deposited in the form of Pay Order/Demand Draft drawn in favor of Punjab Skills Development Fund (PSDF) by the successful bidder within the next Seven (07) working days after the award, failing which PSDF shall be entitled to cancel the bid and forfeit the earnest money deposited with no future claim from the bidder.

18. The vehicles will be handed over to the successful bidder after receiving the full payment.
19. The decision of PSDF's Disposal Committee shall be binding in all cases.
20. Condition of vehicles is unknown and will be on "AS IS WHERE IS BASIS" and PSDF shall bear no responsibility after collection of vehicles by the successful bidder.
21. Successful bidders shall uplift the vehicles within Ten (10) days after depositing the full amount and in case of non-compliance earnest money along with the deposited amount shall be forfeited and bid will be cancelled with no future claim from the bidder.
22. Successful Bidder shall make sure use of the vehicles is strictly in accordance with the prevailing applicable national and international laws. In case of any violation(s), the successful Bidder shall be fully liable without any responsibility to PSDF.
23. Sealed Bid envelop along with necessary documents shall be delivered through courier services or by hand to PSDF on the above-mentioned address not later than **03:00 PM by January 2, 2026**. The Disposal Committee will open the bids on the same day at **03:30 PM** in the presence of the bidders, or their authorized representatives, who may like to be present.

24. PSDF employees & their families and Government Employees will not be entitled to participate in the disposal process.
25. The earnest money of the unsuccessful participants will be released within 5 days after the issuance of the award letter whereas the earnest money of the successful bidder will be adjusted against the remaining payments.
26. Evaluation shall be made at total of Individual bid price for each vehicle. Bidders can participate in one or more than one vehicle. Incomplete or partially and conditionally filled bids against price schedule will be considered non-responsive for that vehicle.
27. Bidder is required to sign/stamp every page of the disposal document along with signature and submit back along with the bid.
28. One person one bid concept be used for each vehicle and if one person submits more than one bid, the PSDF shall reject all such bids.
29. The interested bidders can **inspect** (verify all the registration book & any other supporting documents before the submission of bid), the vehicles at the above-mentioned address during office hours (**09:30 a.m. to 05:30 p.m.**) on following dates along with a **request for inspection** of the vehicles on the **bidder's letterhead** with authority:-

30. Interested parties must bring their **original CNIC** with them at the time of the opening of the bids.
31. Bid will be considered non-responsive in case of submission of incorrect or non-submission of original earnest money along with the required Bid document.
32. PSDF reserves the right to cancel / reject the disposal of any or all vehicles at any stage without assigning any reason.
